THE FISHERIES (AMENDMENT) REGULATIONS, 2020

Construction

308 of 2009

1. These Regulations may be cited as the Fisheries (Amendment) Regulations, 2020 and shall be read as one with the Fisheries Regulations, 2009 herein referred to as the “principal Regulations”.

Amendment
of regulation
2

2. The principal Regulations are amended in regulation 2 by inserting in its alphabetical order the following definitions-

“blue economy” means a sustainable economic development of oceans using such techniques as regional development to integrate the use of seas and oceans, coasts, lakes, rivers, and underground waters for economic purposes including, but not limited to fisheries, mining, energy, aquaculture and maritime transport, while protecting the sea to improve social wellbeing;

"dagaa seine net" means a surrounding net with head rope with floats and foot rope with sinkers subjected to float which is operated at night with light attraction targeting small pelagic species locally known as *dagaa*;

“fisheries cooperative” means a fisheries group registered under the Cooperative Societies Act;

"fish importer" means any person bringing into the country any fish or fishery product or aquatic

- flora from any place outside Mainland Tanzania;
- "fish exporter" means any person taking away fish, fishery product or aquatic flora from the country to any other place outside Mainland Tanzania;
- "fishing gear importer" any person bringing into the country any fishing gear or fishing gear accessories from any place outside Mainland Tanzania;
- "fishing gear exporter" means any person taking away fishing gear or fishing gear accessories from the country to any other place outside Mainland Tanzania;
- "gutted whole fish" means fish whose guts (*viscera*) have been removed;
- "fishing gear manufacturer" means a person, group or company who produce fishing gear or fishing gear accessories;
- "head and gutted fish" means fish whose head and guts (*viscera*) have been removed;
- "ring net" means a surrounding net with a head rope with floats and bottom foot line with sinkers and rings, through which a purse line is inserted to form a purse during operation;
- "seine net" means a fishing net that hangs vertically in water with floats at the top and weights at the bottom edge, the ends being drawn ashore or on to a vessel to encircle the fish; and
- "trap" means simple, passive fishing gear with a mouth size of entrance which allow determined size of fish to enter and make it hard for fish to escape.

3

3. The principal Regulations are amended in regulation 3 by-

(a) adding immediately after subregulation (2) the following-

"(2) The officer in charge of fisheries from local authority shall be responsible to

report on all fisheries related matters to the Director.”

(b) renumbering subregulations (2), (3), and (4) as subregulations (3), (4) and (5) respectively.

11

4. The Principal Regulation are amended in regulation 11 by deleting subregulations (1) and (2) and substituting for them the following:

“(1) A person shall not use, employ, cause or permit another person to use any fishing vessel for fishing purposes unless such vessel has been licensed in accordance with these Regulations.

(2) A fishing vessel with an overall length of above eleven metres or twenty Gross Tonnage shall be approved and licensed by the Director.”

13

5. The principal Regulation are amended in regulation 13-

(a) by deleting the “marginal note” and substituting for it with the following:

“Engage in fishing, export or import of fish or fishery products”.

(b) in subregulation (1), by inserting immediately after paragraph (b) the following-

“(c) engage in export, import or cause another person to engage in such activities under paragraph (a) and (b);”

(c) renumbering paragraph (c) as paragraph (d);

(d) adding immediately after paragraph (d) as renumbered the following:

(e) be granted a business license for import or export of fish and or fishery products unless such person obtains an approval from the Director”.

(e) by deleting sub regulations (14), (17) and (18) and substituting for them the following:

“(14) A non-citizen or fish establishment owner shall not engage in

fishing, collect fish or fishery products of any kind within Mainland Tanzania.

(17) An application for renewal of export or import license shall be enclosed with bank statement or any other proof of payment for exported consignment and export *or import* performance report as set out in Form 3(d) or 3(e) of the First Schedule.

(18) A non-citizen shall, on applying for or dealing on export or import of fish or fishery products fill Form 3 (c) as prescribed in the First Schedule under these Regulations, and attach Certificate of Incentives issued by the authority responsible for investments, a proof on the value of physical investment relevant to fisheries activities, Certificate of Incorporation, Memorandum and Articles of Associations, and Business Plan, proof of citizenship, Tax Identification Number (TIN), Tax Clearance Certificate and work permit.”

(f) by adding immediately after subregulation (18) the following:

“(19) Without prejudice to subregulation (18), upon renewal of a license such person shall also attach an Audit report of establishment or Processing facility and Bank Statement or any proof of payment, Official Search Document from Authority responsible for Business Registration and Licensing and Export or Import Performance Report of previous year.”

(g) by renumbering paragraphs (19) and (20) as paragraphs (20) and (21); and

(h) adding immediately after paragraph (21) as renumbered the following:

“(22) A citizen shall, on applying for export or import of fish or fishery products fill application Form 3 (c) as prescribed in the First Schedule under these Regulations and attach Certificate of registration, Extract from

Registrar, Certificate of Incorporation, Memorandum and Articles of Associations, Proof of Citizenship, Tax Identification Number (TIN) and Tax Clearance Certificate.

(23) Without prejudice to sub regulation (22), upon renewal of a license such person shall also attach an audit report of establishment or processing facility, Bank Statement or any proof of payment, Official Search Document from Authority responsible for Business Registration and Licensing and export or import performance report of previous year.”

Amendment

18

6. The principal Regulation is amended in regulation 18 by-

(a) deleting subregulation (3) and substituting for it the following:

“(3) A sport fishing licence shall be issued by the Director and may be issued for a fortnight, one month or one year and such licence shall unless previously cancelled continue to be valid”.

(b) inserting immediately after subregulation (3) the following:

“(4) Without prejudice to sub-regulations 13(1)(a) and (c) and 18(2) a person with a previous year expired licence may be allowed to carry out fishing as may be determined by the Director.”

(c) designating the contents of subregulation (2) appearing after subregulation (3) as (5).

20

7. The principal Regulations are amended in regulation 20 by adding immediately after subregulation (3) the following:

“(4) The master of a fishing vessel in respect of which a commercial license or permit has been issued, shall record daily and maintain fishing and landing logbook as prescribed on Form No 14 of these

Regulation.

(5) The master or owner of the fishing vessel concerned, not later than twenty four hours after completion of landing, shall deliver both the fishing logbook and the landing logbook sheets to an Authorized Officer.

(6) The northern zone fishing shall be closed on 30th September and re-opened on 1st March of each calendar year.

(7) The southern zone fishing shall be closed on 31st August and re-opened on 1st April of each calendar year.”

24

8. The principal Regulations are amended in regulation 24 by deleting subregulation (1) and substituting for it the following:

“(1) Every investor and stakeholder shall abide to the guidelines issued by the Director on areas for developing the fishing industry in line with the continental blue economy concept.”

Addition of
regulation
25A

9. The principal Regulations are amended by inserting immediately after regulation 25 the following:

“Establishment of Fisheries Cooperative Societies 25A.-(1) There shall be Fisheries Cooperative Societies established in accordance to the Cooperative Societies Act.

(2) The Director shall, in collaboration with other relevant authorities, create conducive environment for development of fisheries cooperative societies in the areas of fishing, processing and marketing.”

50

10. The principal Regulations are amended in regulation 50, by –

- (a) deleting subregulations (3) and (4) and substituting for it the following:

“(3) An Authorized Officer shall, subject to the provisions of these Regulations, compound such offences as set out in the Seventh Schedule after accepting a sum of money not exceeding one half of the amount of the fine to which such person would otherwise have been liable to pay if he had been convicted of an offence.

(4) An authorized officer shall, upon compounding an offence specified under Part A and B of the Seventh Schedule, fill and issue Compounding Form No. 11 and Compliance Form No. 27.

(5) An authorised officer shall, after seizure of perishable fish or fishery products apply to the court within five working days for an order for disposal of the seized fish or fishery products by using form 13(a) as set out in the First Schedule.

(6) Upon issuance of disposal order under subregulation (5), the authorised officer shall be required to -

- (a) in the case of disposal by destruction, fill form 13(c) as set out in the First Schedule;
- (b) in the case of disposal by distribution, fill form 13(d) as set out in the First Schedule.”

(b) renumbering subregulations (5) and (6) as subregulations (7) and (8) respectively;

(c) adding immediately after subregulation (8) as renumbered the following:

“(9) For properties other than fish or fishery products, procedure for disposal of such properties shall be as prescribed under the Criminal Procedure Act and other relevant legislations”.

Amendment
of regulation
51

11. The principal Regulations are amended in regulation 51 by-

- (a) designating the contents of regulation 51 as subregulation (1);
- (b) inserting the words “which may affect health of

aquatic ecosystems” immediately after the word “seawater”;

(c) adding immediately after subregulation (1) as designated the following:

“(2) Unless provided otherwise, the provisions of the Environmental Management Act, shall apply to offences involving discharge of pollutants under these Regulations.”

Amendment of regulation 54

12. The principal Regulations are amended in regulation 54 by adding immediately after subregulation (7) the following-

“(8) Closing period in *Gazetted*, critical habitat in Lake Victoria shall be from 1st March to 30th June of each calendar year;

(9) Fishing shall not be allowed in *Gazetted* critical habitats in Lakes Tanganyika and Nyasa.

(10) The Minister may at any time close fishing in any water body to allow stock recovery or for any other purpose as it deems fit.”

Amendment of regulation 58

13. The principal Regulations are amended by deleting regulation 58 and substituting for it the following-

“Fishing in Lake Victoria

58.-(1) A fish establishment owner shall not carry out fishing activities in Lake Victoria.

(2) Notwithstanding the provisions of subregulation (1) a person shall not-

(a) fish, land, possess, process, export or trade in Nile perch or fish locally known as “*sangara*” the total length of which is below fifty centimetres for fresh fish:

Provided that an acceptable standard error of

not exceeding minus two centimetre (-2cm) of Nile Perch slot size may be allowed.

- (b) land, possess, export or trade in Nile perch or fish locally known as “*Sangara*” the total length of which is below an acceptable standard error of not exceeding minus 3 centimetres (-3cm) may be allowed for sundried, smoked or fried fish;
- (c) collect, possess, land, store, process, trade or export in Nile Perch fish maws locally known as ‘*mabondo*’ of the length less than 12 cm or 13 grams for fresh and 8cm or 4 grams for dried fish maws;
- (d) a person shall not fish, land, collect, store, possess, export, or trade in Nile tilapia fish species or fish locally known as “*Sato*”, or “*ngege*” with total length which is below twenty five centimeters (25cm) except for farmed.”

(3) A person shall not use or cause another person to use a gillnet panelling (vertical integration) of more than 78 meshes and not less than 6 inches mesh size for Nile Perch fishery in Lake Victoria.”

Addition of
new
regulations

14. The principal Regulations are amended by inserting immediately after regulation 58 the following new regulations as follows:

Fishing in lake 58A.-(1) A person shall not use or cause another person to use a gillnet

Tanganyika and lake Nyasa panelling (vertical integration) of more than 144 meshes and less than 3 inches of less than 4 ply and more than 6 ply for fishery in Lake Tanganyika.

(2) A person shall not fish or cause another person to fish, land, possess, process, export or trade in fish locally known as “*mgebuka*” the total length of which is below twenty six centimetres.

(3) A person shall not fish or cause another person to fish, land, possess, process, export or trade in fish locally known as “*dagaa*” or with any other name as it may be called the total length of which is below seven centimetres.

(4) A person shall not fish tilapia from Lake Tanganyika, Lake Nyasa, Nyumba ya Mungu dam and Mtera dam with total length less than 20 centimeters.”

Fishing in other water bodies 58B. Fishing in lakes Eyasi, Manyara, Kitangiri, Rukwa, Singidani, Basuto, Burigi and Bahi swamp and rivers other than River Kilombero and other minor water bodies, shall be conducted in accordance with fishing guidelines approved by the Director.

Harvest and sell farmed fish 58C. The Aqua farmer who intend to harvest and sell farmed fish shall obtain a special permit for transportation or display of such fish from Fisheries Officer or any other Authorized Officer.”

Amendment of regulation 59

15. The principal Regulations are amended in regulation 59(1) by-

(a) deleting paragraph (a) and substituting for it the following-

“(a) lobster of the family *palinuridae* (spiny lobster) whose individual weight is below five

hundred grams;

(b) inserting immediately after paragraph (a) the following:

(b) lobster of the family *scyllaridae* (sandy lobster) whose individual weight is below two hundred and fifty grams;”

(c) renumbering paragraphs (b), (c), (d) and (f) as paragraphs (c), (d), (e) (f) and (g) respectively;

(d) adding immediately after subregulation (2) the following:

“(3) A person shall not trade or export processed octopus whose individual weight is below four hundred and forty grams”.

Amendment
of regulation
66

16. The principal Regulation is amended in regulation 66(1) by-

(a) deleting paragraph (f) and substituting for it the following-

“(f) manufacture, possess, store, sell, use or cause another person to use for fishing a gill net of mesh size less than three inches or 76.2 millimetres with more than six ply’ in any water body except for Lake Victoria as prescribed in sub regulation (3);”.

(b) deleting paragraph (n) and substituting for it the following-

“(n) carry out any fishing activity using trawl net or otherwise engage in trawling in any fresh water body except for prawn in marine waters, research and training;”

(c) deleting paragraph (r) and substituting for it the following:

“(r) order or import fishing net and netting materials for capture fisheries without a permit issued by the Director;”

(d) deleting the “full-stop” appearing at the end of paragraph (x) and substituting for it “semi colon” and adding thereunder the following:

“(z) use fishing traps known as “*madema*” or with any other name as it may be called in any other

water body with mesh size less than 3 inches;

(aa) use Iron bars locally known as “*michinjĩ*” or “*mitaimbo*” or with any other name or similar tools as it may be called in fishing octopus in marine waters;

(bb) use or cause another person to use modified seine nets;

(cc) use or cause another person to use legal fishing nets mixed with patches of illegal fishing nets;

(dd) use or cause another person to use ring net or purse seine for fishing during day time in marine waters;

(ee) use or cause another person to use ring net for fishing in Lake Tanganyika unless operated in not less than 1000m range from the shoreline, island or Peninsula with light attraction during night time

(ff) use or cause another person to use ring net or purse seine for fishing in marine waters operated in depth of less than 50m during low tide;

(gg) use or cause another person to use generator as a source of light or any other source of light that has not been approved under this regulation for attracting fish during fishing in any water body;

(hh) use or cause another person to use solar light bulbs in Lake Tanganyika with capacity of more than 10 watts, and a total number of bulbs per boat not exceeding five (5) for a single unit of fishing gear;

(ii) use or cause another person to use solar light bulbs in Lake Victoria with capacity of more than 10 watts, and a total number of bulbs per boat not exceeding nine (9) for a single unit of fishing gear;

(jj) manufacture fishing nets, fishing hooks, fishing lines, fishing twines and other fishing gear accessories for commercial purpose without an approval from competent authority;

(kk) use hooks with sizes above 9 for lates species, *singa*, *kuhe* and *poroko/kavungwe* fishery and above 12 for species other than lates species, *singa*, *kuhe* and *poroko/kavungwe* in Lake Tanganyika;

(ll) use hooks with sizes below 13 and above

14 for tilapia fishery in Lake Victoria;

(mm) carry out *dagaa* or *haplochromines* (*furu*) fishing without light attraction;

(nn) carry out fishing by using *dagaa* net during moonlight and day time;

(oo) use gillnet of mesh size less than 1.5 inches 4 ply in Lake Nyasa for species locally known as “*vitui*”; and

(pp) introduce or cause another person to introduce a new type, method, or technology of fishing gear in any water body without the consent of the Director.”

(e) by deleting sub regulation (3) and substituting for it the following:

“(3) Notwithstanding sub-regulation (1)(e) a person shall not possess, import, sell, use or cause another person to use for fishing, a gill net of mesh size less than six inches or 152.4 millimetres and nine ply in Lake Victoria except for research and training purposes.”

(f) adding immediately after subregulation (3) as amended the following-

“(4) Any person intending to import fishing nets or netting materials on application for an import permit shall submit specification of gears intended to be imported before commencement of importation procedures as prescribed in Form No.QA/APP/16 under the Fifth Schedule.

(5) A person who contravenes this regulation commits an offence and on conviction shall be liable to a fine not less than two million shillings and not exceeding ten million shillings or imprisonment for a term of not less two years and not exceeding five years or to both such fine and imprisonment except for manufacturer, supplier, trader, distributor or importer.

(6) Fishing gear manufacturers or supplier shall seek approval from the Director of Fisheries

before commencing such business and be granted an Approval Certificate.

(7) Without prejudice to sub regulation (6) such Approval Certificate shall be valid for one year.

(8) The Director of Fisheries shall establish a register, keep records and verify systems for the purpose of traceability of fishing gears supply from manufacturer to the water body or client-

(a) in the case of quarterly verification, an authorised officer shall carry out inspection using reference standard prescribed under Form QA/RS/31a as set out in the Sixth Schedule;

(b) in the case of imported fishing gear at the point of entry, the verification shall be conducted using Form QA/RS/31b as set out in the Sixth Schedule.

(9) A manufacturer, importer, trader, distributor, or supplier who contravenes this regulation, commits an offence and upon conviction shall be liable to a fine of not less than ten million shillings and not exceeding fifty millions or imprisonment to a term of not less than three years and not exceeding six years or to both such fine and imprisonment.

(10) For the purpose of measuring a mesh size of any fishing net, the measuring instrument shall be a Mesh Gauge which is-

(a) expressed in millimetres or inches;

(b) measured from inside the knots or joints (mesh opening); and

(c) measured by opening the mesh, stretched in the N-direction of the mesh and the gauge inserted into the mesh opening in the direction perpendicular to the plane of the net by inserting the gauge by manual force until the resistance of the mesh begins.

(11) Without prejudice to sub regulation 66 (1)(jj) the manufacturer shall be required to produce production performance report in the manner set out in Form 3(d) or 3(e) of the First Schedule.”

Amendment
of regulation
128

17. The principal Regulations are amended in regulation 128(1) by deleting paragraphs (a) and (b) and substituting for it the following-

- (a) in case of first offences involving unlawful fishing or fish trading or facilitating unlawful fishing or fish trading, to a fine of not less than ten million shillings but not exceeding thirty million shillings or to imprisonment for a term of not less than two years and not exceeding five years or to both;
- (b) in the case of second and subsequent offences of paragraph (a), be liable, to a fine of not less than ten million shillings but not exceeding fifty million shillings or to imprisonment for a term of not less than three years and not exceeding six years or to both; and
- (c) in case of offences other than offences under paragraphs (a) and (b), be liable to a fine of not less than two hundred thousand shillings but not exceeding ten million shillings or to imprisonment for a term of not less than two years and not exceeding five years or to both.

Amendment

18. The principal Regulations are amended-

- (a) generally in the Schedules by deleting the words “(The Fisheries (Amendment) Regulations, 2009)” appearing before the enabling provisions.
- (b) in the First Schedule by-
 - (i) deleting Form No.3(c) and 3(e) substituting for them the following-
